Specific Hunting destinations if known upon contract may be named below, however due to the unique nature of Big "E" Outfitter's Services the client and the destination are matched based on a number of criteria which may not be available until closer to the actual hunt date. The hunt is booked with Big E Outfitters and is secured by same. Destinations are subject to change to suit the best experience for the client without notice.

Big E Outfitters/Ranch's accept only a limited number of guests on their private hunts on first come first serve basis. Therefore, it is important that openings during the short seasons are filled and do not go unused due to cancellations. For this reason, the deposits for hunts are **nonrefundable** if the guest cancels the hunt. If for some reason the Outfitter cancels the hunt, the deposit will be refunded. The Outfitter reserves the right to cancel any hunt at any time for any reason. The Outfitter reserves the right to use any photographs, video footage, hunt stories and names for marketing purposes, business enhancing opportunities, and/or profitable strategies for the Outfitter Service or ranch.

#### Successful guests are required to deliver to the outfitter copies of photos of film footage taken during their hunt.

I, the hunter or party, accept full responsibility for any injury I may incur while hunting with BIG "E" Outfitters, Nation, TV /and/or any of its affiliate ranches or outfitter services. I, the hunter or party, will inspect the safety of any tree stand or step before using it. I accept full responsibility for any tree stand, ladder stand, tower stand, blind or other stand I use and the height in which it is at. Furthermore, I will use all safety harnesses and equipment provided by the Outfitter at all times. I the Hunter and/or Party have read and understand and agree to, without reservation, all terms and conditions, outlined in this contract and agrees to all items, terms, and situations stipulated above.

#### 3. NONREFUNDABLE/TRANSFERABLE DEPOSIT

Deposit is non-refundable but is transferrable to another date. Hunter may transfer his deposit to another date or another hunt. If notice is given in reasonable time. Prices and fees pertaining to that hunt year and hunt selection will apply and a transfer fee may apply. Transfer of deposit is only available up to 60 days prior to the scheduled hunt. Within a 60 day window of a scheduled hunt a deposit may be forfeited for cancelation.

#### **4. TRANSPORTATION**

Hunter and Party hereby acknowledges and agree that unless specified herein, the outfitter is not responsible for transportation of Hunter and Party, or Hunter and Party's equipment to or from any of Big E's facilities or hunting areas or any of its assigned outfitters areas.

#### 5. DISCLAIMER AND LIABILITY WAIVER

Hunter and Party acknowledge the inherent risk of hunting big game and traveling by vehicle or any other conveyance, and/or horseback in the hunting areas and on both public and private lands and agrees on behalf of Hunter and Party and Hunter and Party's heirs, executors and assigns, to hold the Outfitter or ranch its agents, servants, employees and representatives harmless and indemnify them from and against any and all claims and liabilities, including but not limited to court cost and legal expenses, which may arise by reason of any bodily injury or death to Hunter and /or Party, and/or other people, and /or reason of any damage to property, and/or any reason of loss of time, and/ or any other loss, real or perceived and/or as outlined below.

**Activities**- Hunter and Party, accepts and acknowledges, by signing this contract, that all activities sponsored and/or conducted by the outfitters or it facilities, may be hazardous, and/or potentially dangerous because of the use of firearms/bows by hunters of varying degrees of proficiency, during such hunts, any and all unrestrained wildlife or domestic animals, which may result in accident, loss, damage, injury or death. Further, Hunter and Party fully acknowledge and do hereby voluntarily release all activities sponsored or conducted by the Outfitter or Ranch, by Hunter and Party.

#### **6.RULES, LAWS AND ETHICS**

Hunter and all members of the Party agree by signing this form to follow all rules, laws and ethics provided herein and/or posted or provided at each of our facilities, or that may be added at any time for safety or clarification. These rules, laws and ethics include but are not limited to the following:

**A.** Compliance with all federal and state game laws is mandatory.

**B.** No loaded guns outside of designated hunting areas, this includes in vehicles or in lodging areas.

C. No shooting from vehicles.

**D.** No Hunter shall hunt on any Ranch without a guide unless it is an open range hunt.

**E. Absolutely** No private vehicles on the property unless escorted by a guide without prior approval by ranch management this includes personal ATV's.

**F.** All minors must be accompanied by an adult while hunting, and must show proof of completion of a hunting safety course.

**G.** No alcoholic beverages are allowed in blinds or hunting fields or when in contact with any firearm or animal. If it is found that alcohol is consumed while hunting the hunter may be requested to leave with no refund of any deposits paid.

**H.** Anyone under the influence of alcohol or drugs will not be allowed to hunt.

I. No illegal drugs will be allowed on the property of ANY BIG E Outfitter affiliate.

**J.** Hunters will conduct themselves in a sportsman-like manner at all times, both in the field and at the lodges.

**K.** Safety is most important. All hunts are guided and you must have clearance to shoot before you attempt to harvest an animal at any of the locations contracted by BIG "E" outfitters.

L. All animals which have been hit are considered a kill. Hitting an animal and drawing blood or hair deems the hunt successful. All reasonable efforts will be made to recover your animal. Regardless of the outcome it is ultimately your decision to release an arrow or a bullet. The result is YOUR responsibility and you are liable for any animals hit, maimed, grazed or injured as a result. SEE NOTES FOR EXCEPTIONS

M. Scoring. At all locations under contract with Big "E", scoring is done by a total net score,

with no deductions. Hunters will be allowed to be present during scoring and all disputes must be settled on each measurement. Once the scoring is complete there is NO RECOURSE and no credits will occur. Many animals are priced by sight... meaning they are pointed out and priced as seen. In this case score is not a factor. Disputes after the fact, cannot be addressed. They must be settled on site at the time of scoring.

N. Each Hunting destination will may their own safety regulations and liability waivers which must be signed prior to hunting in addition to this contract.

» Any person who does not comply with the above rules will be removed from the property,

losing any additional hunting rights to the outfitters property and all fees and deposits that have been paid.
