**RIB MOUNTAIN BOWMEN, INC.
MEMBER LIABILITY WAIVER AND RELEASE**

In consideration of membership in Rib Mountain Bowmen, Inc. and the opportunity to enter Rib Mountain Bowmen, Inc.'s property as part of my membership, I agree to the following:

Appreciation and Assumption of Risk: The risk of injury from the activity of archery, the weaponry involved in archery, and conditions that exist on the archery course is significant. I understand that entering onto the property is voluntary and done at my own risk. While particular safety practices and personal discipline will minimize this risk, the risk of serious injury, including the potential for permanent disability or death does exist. I acknowledge such risks and assume full responsibility for my participation.

Range Rules: I willingly agree to comply with the customary safety precautions of archery as well as the terms stated in Rib Mountain Bowmen, Inc.'s Range Rules. If I observe any unusual or unnecessary hazard, I will bring such to the attention of the supervisor on duty immediately.

Release of Liability – Negligence: I assume full responsibility for the risk of bodily injury, death, and property damage due to negligence. I release and hold harmless Rib Mountain Bowmen, Inc., its members, directors, officers, volunteers, representatives, and the agents of the foregoing, from all claims of negligence associated with my involvement as a member of Rib Mountain Bowmen, Inc. either while competing, officiating, working, spectating, or for any purpose. I do this for myself, and on behalf of my heirs, personal representative, assigns, or any other third party.

Medical Services: I understand and agree that medical or other services rendered to me by, or at the direction of, any of the persons or entities mentioned above is no an admission of liability to provide or to continue to provide any such services, and is not a waiver by any of the persons or entities mentioned above of any right hereunder.

Bargain: Because I wish to be a member of Rib Mountain Bowmen, Inc. and enter on Rib Mountain Bowmen, Inc.'s property, and I do not wish to pay a higher fee to be a member, I hereby waive to the right I have to bargain for different waiver of liability terms.

I understand my membership in Rib Mountain Bowmen, Inc. and entry on to its property is voluntary. I have read this Liability Waiver and Release, and I understand and accept its terms and provisions. I understand that I have given up substantial rights by signing this Liability Waiver and Release and sign it voluntarily without any inducement.
