





# Recall Walker Efforts Begins

As promised, groups made up of Democrat activists and labor unions registered and began their efforts to recall Governor Scott Walker on Tuesday, November 15. This effort has until mid-January to collect just over 540,000 signatures to trigger a recall election against Walker.

540,000 signatures in 60 days is a tall order but unfortunately you have to assume that this group will be successful in their efforts and we will be going through another campaign cycle in advance of the general elections in November of 2012.

WBA along with groups that were supportive of Governor Walker in 2010 and his efforts to get Wisconsin back on track in 2011 have already been meeting and planning the counter effort to this vendetta against Walker in 2011-2012.

# May or June

From the head of the Government Accountability Board to those running Governor Walker's campaign, most seem to be looking at May or June 2012 as a date for voters to go to the polls to vote again for a Wisconsin governor.

Once signatures are turned into the Government Accountability Board they are reviewed and certified (and possibly challenged for their authenticity) before a primary and general election date would be set. The sheer volume of signatures that must be reviewed and certified will take a great deal of time.

Expect legal challenges and the possibility of a primary election to determine a candidate to run against Walker. This would only further push back the date of a recall general election.

The estimate of May or June seems accurate as of today, but any of the above scenarios could push that date further into the summer of 2012.

# State Senate Recalls 2.0

The state Senate is also gearing up for additional recall elections. As of right now four Republican state senators face recall elections this spring. Three freshman senators, elected in November of 2010 and Senate Majority Leader Scott Fitzgerald (R-Juneau) all face the threat of recall elections. The three freshman legislators are Senators Van Wanggaard (R-Racine), Terry Moulton (R-Chippewa Falls) and Pam Galloway (R-Wausau).

The Committee to Elect a Republican Senate (CERS) has been gearing up for this possibility for weeks and already have two full time staff members charged with raising funds and planning campaigns in these four districts.

Majority Leader Fitzgerald represents an overwhelmingly Republican district and many question if the required signatures will even be obtained to actually trigger a recall election. Wanggaard's Racine area district has flipped back and forth between the parties for twenty years. Moulton's district was held by a Democrat for four years and Republican Dave Zien prior to that. Galloway's district had been in Democratic hands since 1991.

As of today the state Senate recall elections would be run on the maps that the senators ran on in 2010, the "old maps." If they were to run on the "new maps" passed by the legislature this summer, it would have a profound effect on these elections. The Wanggaard seat becomes an overwhelmingly GOP district and would not be up for grabs. The other seats (Moulton and Galloway) change less dramatically but still become more GOP than the configuration that they ran on in 2010.

# Use Builders Direct Fund Conduit (BDF) For Recalls

An important reminder, if you are going to be giving to Governor Walker or any state senator that is up for recall, be sure to make those contributions through the Builders Direct Fund Conduit.

Giving to the Builders Direct Fund Conduit allows you to make personal contribution to candidates while allowing your local association to get credit for the contribution and WBA to receive additional recognition for the donation.

# Natural Resource Committees review DNR Reg Reform Bill

Recently the Assembly and Senate Natural Resources committees meet in a joint session to take testimony on Special Session Bill 24 (SSB 24). SSB 24 makes a number of changes to improve many regulatory procedures by the Wisconsin Department of Natural Resources (DNR).

The hearing took in the neighborhood of nine hours to complete because a number of groups raised the dreaded "m word" in response to this bill---mining. Speaker after speaker made the claim that this bill was a back door way to move forward to get a mine approved in northern Wisconsin. This bill makes a number of important regulatory changes concerning the DNR, but none of them deal with mining.

WBA fully supports SSB 24, specifically provisions dealing with streamlining grading permits and the inclusion of Assembly Bill 117 that deal with a streamline Chapter 30 permit and presumptive approval of Chapter 30 permit applications.

In addition to the current bill, WBA is also asking legislators to include a provision to establish a process to better determine the ordinary high water mark. This provision was passed during the 2005-2006 legislative session but was vetoed at the request of DNR by Governor Doyle.

# Landlord-Tenant bill moves on to Governor Walker

Recently the state assembly took final action on Senate Bill 107 (SB 107), authored by state Senator Frank Lasee (R-De Pere) to restrict what local municipalities can act on in local ordinances concerning rental properties.

SB 107, as amended, prohibits a city, village, town, or county from enacting an ordinance that does any of the following with respect to a residential landlord:

- 1) Prohibits or limits the landlord from obtaining or using various types of information about a tenant or prospective tenant, such as household income, occupation, court records, rental history, and credit information
- 2) Limits how far back in time a prospective tenant's credit information, conviction record, or previous housing may be considered by the landlord
- 3) Prohibits the landlord from showing a rental property to a prospective tenant, or from entering into a rental agreement for a rental property with a prospective tenant, while the current tenant is living there.
- 4) Enacting an ordinance placing requirements on a residential landlord with respect to security deposits, earnest money, pretenancy inspections, or posttenancy inspections beyond those requirements found in the state administrative rules.

# Governor's order marks beginning of accountability for state regulations By WBA Executive Vice-President Jerry Deschane, CAE

Governor Walker recently signed Executive Order #50, implementing a law passed by the legislature during the January special session. The bill requires the Governor to sign off on new or revised rules promulgated by his or her agency. The Executive Order establishes a detailed process agencies will have to follow, including a requirement that agencies have to consult with industry groups, including their trade associations, before moving ahead with a rule that will impact that industry. While the details of the rule fall squarely into the category of "inside

baseball," and would only interest the worst government geeks (like us!), they mark a dramatic shift to the better in terms of public accountability.


# WHEDA loan expansion passed

Special Session Bill 2 (SSB 2) also got signed off on recently from both houses of the legislature.

SSB 2 was sponsored by Senator Joe Leibham (R-Sheboygan) and Representatives Warren Petryk (R-Eleva) and Kathy Bernier (R-Chippewa Falls) and will make a number of changes to current requirements for WHEDA loans.

Currently WHEDA administers the small business development loan guarantee program. Under the program, WHEDA may guarantee repayment of up to the lesser of \$200,000 or 80 percent of the principal of a loan made by a private lender to a small business or the elected governing body of a federally recognized American Indian tribe in this state. A small business development loan that is guaranteed by WHEDA may be used for expenses associated with the expansion or acquisition of a business, with the start-up of a day care business, or the start-up of a small business in a vacant storefront in the downtown area of a rural community.

SSB 2 will change the cap on the amount of a loan that may be guaranteed under the program from \$200,000, or 80 percent of the principal of the loan, to \$750,000, or 80 percent of the principal of the loan; changes the definition of "small business" from businesses that employ up to 50 full-time employees to businesses that employ up to 250 full-time employees; the requirement that the owner of a small business be actively engaged in the small business in order to qualify for the program is deleted, and the permitted use of proceeds of a loan for the start-up of a small business in a vacant storefront in a downtown area is expanded to apply to a community of any size by removing the limitation to rural communities.



This law change may make this loan program more attractive to some members and provide another tool to get financing.
