# THE MONDAY MORNING REVIEW



## **Steineke , Ribble join Advocacy Group**

WBA members who attended the Advocacy Group meeting recently were treated to a presentation by two significant players in state and national politics, Assistant Majority Leader Representative Jim Steineke and Congressman Reid Ribble.

Representative Steineke gave the group an update on issues before the Wisconsin legislature and explained the effort to “Right the Rules” (more info below). Steineke encouraged members to suggest administrative rules that need to be eliminated or modernized for consideration this legislative session.

Congressman Ribble, a surprise and very welcome addition to the meeting, gave the group some background on the negotiations surrounding the “fiscal cliff” and touted the fact that the U.S. Senate had just signed off on his proposal to stop congressional pay unless a federal budget is passed.

We will continue to look for compelling speakers for members who attend the Advocacy Group meetings in the future. Please let me know if you have any ideas for future speakers.

## **"Right the Rules" announced by Assembly GOP**

Assembly Speaker Robin Vos (R-Rochester) and the Co-Chair of the Joint Committee for Review of Administrative Rules Dan LeMahieu (R-Cascade) recently announced an effort to “Right the Rules”.

This effort will fall largely to the standing committees of the state assembly, their chairs and staff, and will focus on reviewing the 11,764 pages of administrative code currently in place in Wisconsin.

“We intend to look at every rule, every chapter in the administrative code to see if it applies today. I think that we’ll find that, in many cases, they don’t apply at all,” said Rep. Dan LeMahieu.

Some of the top issues currently covered in the administrative code include ATPC 110, wall bracing, and the Building Contractor Registration (BCR). If standing committees decide to take on any of the

above rules, WBA will then have multiple options to address these problematic rules since DATCP is already reviewing ATPC 110, the Department of Safety and Professional Services is getting ready to call the Uniform Dwelling Code Council together to consider suggested changes supported by WBA on wall bracing, and we believe we have a good change of addressing the BCR in the state budget.

Finally, the Joint Committee for Review of Administrative Rules is also seeking public input for particularly problematic rules and regulations to review. The public is encouraged to voice their concerns by clicking [here](#).

## **Business Day wrap up**

Recently over 100 members and association staff professionals ascended upon Madison for the annual Business Day in Madison lobby day. With release of the state budget and the circulation of a number of bills during the past week, the timing of our annual legislative lobby day was a perfect way to start the legislative session.

Members were briefed on a number of key issues like moving to a six-year cycle for the review of the Uniform Dwelling Code (UDC), elimination of the Building Contractor Registration (BCR), and support for the modernization of the process for shoreland zoning after annexation. Upon conclusion of the issue briefing, Senator Neal Kedzie and Representative Jeff Mursau and their respective Chiefs of Staff, Dan Johnson and Tim Gary, were presented with awards of appreciation for the efforts on behalf of housing. Kedzie and Mursau were named the WBA Legislators of the Year and Johnson and Gary received the annual awards recognizing legislative staff members.

## **Polling: Walker Above 50%**

A group that has “the goal of promoting sensible education reform and exposing those with a vested

interest in maintaining the status quo” released a poll showing strong support for Governor Walker and expansion of school choice in Wisconsin.

The poll done by the well-known polling firm, Public Opinion Strategies (POS), showed Governor Walker with a 55% approval rating. POS’s polling also showed Walker seeing strong support from independents with 61% approving of his job.

On education issues, the poll found that 62% of those responding rated their local school with an A or B grade. Finally, 61% “supported expanding Wisconsin’s school choice program to allow every Wisconsin child to attend the public or private, including religious schools, of their choice.”

### **Wirtz and Degnan take over Advocacy Group Leadership**

With the installation of new WBA leaders the WBA Advocacy leadership also changes with Mike Wirtz of Wirtz Brothers Construction, Malone WI taking over as the new chair and Abe Degnan of Degnan Design Builders, DeForest as the vice-chair.

With the recent state budget announcement and the legislature gearing up for another busy session WBA and Chair Wirtz and Vice-Chair Degnan have a great opportunity to advocate for a number of changes that will make doing business easier.

Congrats to Mike and Abe as they begin their time as leaders of the WBA Advocacy Group!

Finally, thank you to past Advocacy Chair Brad Ten Pas for your leadership of the new Advocacy Group the past year.

### **Reg Reform Report Mentions DATCP 110**

During the Governor’s annual State of the State he made mention of a Regulatory Review Report that was released earlier that day.

It was clear when reading the report that people in the building industry had taken the time to respond to the survey. One quote from a homebuilder/remodeler states “it is impossible to be in compliance with ATP 110.” Sounds like something we have heard many times in the past.

The new Department of Safety and Professional Services also gets high marks from someone identified as a home builder when they were quoted in the report as saying, “Model everything off DSPS. The folks at DSPS have been great. I love the willingness to work with small business.”

The report lists concerns with DNR 216 relating to erosion control, ATP 111 on basement waterproofing, and an entire section on ATP 110 involving home improvement and remodeling.

Abe Degnan of the WBA Remodeler’s Council began working with staff members at the Department of Agriculture, Trade and Consumer Protection (DATCP) on rule changes relating to ATP 110. You may remember this summer the DATCP board approving the department’s request to move forward with modernizing that rule and we are happy to report that process is underway.

### **2013 Guide to the Wisconsin Supreme Court and Judicial Evaluation**

The Wisconsin Civil Justice Council’s 2013 Guide to the Wisconsin Supreme Court and Judicial Evaluation, which highlights the most important business decisions issued by the court over the past two years, is now available.

According to the report, Justice Patience Roggensack led the court the past two terms with a 74 percent rating in cases favoring businesses, followed by Justices David Prosser, Jr. (70 percent), Michael Gableman (70 percent), Annette Ziegler (68 percent), Patrick Crooks (55 percent), Ann Walsh Bradley (27 percent) and Chief Justice Shirley Abrahamson (17 percent).

The Judicial Evaluation provides information such as how the court decides which cases to take and how the justices voted in each case. The report’s centerpiece is its in-depth summary and analysis of the cases decided by the court that directly affect Wisconsin’s business community.

“The Wisconsin Supreme Court is often the least understood of the three branches of government. The purpose of this report is to educate the public and to highlight the impact the Wisconsin Supreme Court has on the state’s economic climate,” said Jerry Deschane, WCJC Vice President and Executive Vice President of the Wisconsin Builders Association.
