The first step to keeping your personal information safe is being aware that there are a lot of types of scams out there. You may have heard of phishing scams before, but you should also add vishing and smishing to your vocabulary list. Each of these is a type of scam that attempts to acquire your personal information for potential misuse.

- · Phishing is the act of trying to acquire personal information by impersonating a trustworthy source in an email or instant message.
- Vishing is the telephone version of phishing (or voice phishing) where scammers attempt to acquire personal information through an often computer-generated phone call.
- · Smishing is the text message version of phishing (or SMS phishing) when a text, often containing a fraudulent URL or phone number, is sent in an attempt to acquire personal information.

To protect yourself and your personal information there are a few simple tips that you can follow.

- Do not give out information such as your social security number, credit card account number, passwords or bank account information to any incoming caller. Most companies will not request this information unless you initiate the call.
- · If you receive an "urgent" voicemail, text or call about an account, defer to the phone number on your credit card, statement, or the company website to call and check your account status.
- Do not click on suspicious links, open attachments that you were not expecting or visit links from unknown sources in an email or text message.

# UDC Council meets on wall bracing/UDC review

In September the new look Uniform Dwelling Code Council (UDC Council) met for the first time in several months to take up two big tasks, a code change regarding wall bracing and a complete review of the Uniform Dwelling Code.

A law change supported by WBA that passed last session streamlined the council to 11

members and changed the terms of service from 3 years to 2 years. This was the first time the council met since those legislative changes took place in 2012.

WBA was able to present to the UDC Council our plan to simplify the UDC language pertaining to wall bracing. This was the product of the WBA Wall Bracing Subcommittee chaired by Brad TenPas that has been deliberating and studying this issue for over a year.

Members of the UDC passed two motions and asked DSPS staff to work with WBA staff professionals and members to make slight revisions and present a revised package either in October or November, depending on when those revisions can be made. I would describe these changes as minor in scope. For instance, one table needed to be changed to make it clear it accounted for three-story homes.

To move this process forward, a conference call was held with DSPS staff to start the process of drafting these provisions.

Finally, the council also determined that they would take a twofold approach to reviewing the UDC between now and July 2014. During each UDC Council meeting, which plans on meeting each month, they will review changes to the IRC and compare those to the current UDC and have a section where they review problems with the current UDC and talk about those changes.

The UDC Council got off to a great start with the selection of two new leaders, more on that below.

# Coello and Schroeder named UDC Council chair and vice-chair

Before adjourning the UDC Council meeting, members voted on a chair and vice chair to lead their discussions moving forward. The council made very wise choices when they named WBA members Mike Coello UDC Council Chair and Mary Schroeder Vice-Chair.

Having strong leaders like Mike and Mary steering the ship for the UDC Council as they get consensus on wall bracing changes and reviewing the UDC will go a long way to making needed improvements moving forward. Congratulations to Mike and Mary! We look forward to working with you to achieve further clarifications and modernizations of the UDC Code and the wall bracing code.

## Freshman representative introduces vested rights bill

Recently, freshman State Representative Dave Murphy (R-Greenville) circulated a bill for co-sponsorship dealing with vested rights.

The Wisconsin Realtors Association<sup>®</sup> got the ball rolling on this effort by working with Representative Murphy on the draft. Representative Murphy is a former real estate broker.

Some parts of the state statutes were changed on the topic of vested rights during the 2009-2010 session when WBA was able to pass a bill dealing with vested rights and platting reforms that the former WBA Development Council worked on.

Under this bill, if a person has submitted an application for a permit or authorization for building, zoning, driveway, stormwater, or other activity related to residential, commercial, or industrial development (approval), the political subdivision must approve, deny, or conditionally approve the application based on regulations, ordinances, rules, or other properly adopted requirements in effect at the time the application for an approval is submitted to the political subdivision (existing requirements).

In addition, if a project requires more than one approval or approvals from more than one political subdivision, the existing requirements applicable in each political subdivision at the time of filing the application for the first approval required for the project are applicable to all subsequent approvals required for the project.

Passage of this bill will provide great assurance to builders and developers moving forward of the playing field that they must navigate through to get from point A to point B.

## Assembly Democrat attacks "builders and realtors"

Starting last session both Governor Walker and Democrat members of the state senate and assembly have started doing weekly radio addresses to touch on important issues they are focusing on during the legislative session. This week Governor Walker focused his radio address on the topic of "growing our economy by partnering with small businesses."

Recently Wisconsin Democrats selected State Representative Nick Milroy (D-South Range) to deliver their weekly radio address, "protect Wisconsin's outdoor heritage." During the radio address, Representative Milroy criticized the wetland legislation passed last session that WBA supported by saying, "for example, they {the republican majority and Governor Walker} rewrote the wetlands preservation laws to pave the way for the development of our rapidly vanishing waterfowl habitat."

The next line of the radio address is where Representative Milroy attacked both WBA and the Wisconsin Realtors® Association (WRA) when he added, "they {the republican majority and Governor Walker} are currently rewriting our shoreline zoning laws to cater to builders and realtors with little regard for the fish and wildlife populations that depend on these important habitats."

Everyone reading this has been around politics long enough to know that different groups and members of different political parties approach public policy in a different way and have different opinions, that is a given. The disappointing thing about the statements by Representative Milroy is that he infers that the GOP and WBA/WRA support the wetlands bill and revisions to NR 115 and have no regard for the environment. Those statements are not only false but do very little to continue the dialog between parties that disagree on public policy items in an attempt to find common ground in the future.

## Van Hollen's surprise announcement

Two-term Wisconsin Attorney General J.B. Van Hollen announced that he would not be seeking reelection to the office he was first elected to in 2006. Van Hollen bested Kathleen Falk in a close election in 2006, one of the few statewide GOP candidates to win in an election year where the GOP was trounced across the country.

Normally when an announcement like this comes out there have been rumblings and rumors leading up to it, but this time around it was truly a surprise with no prior warning of Van Hollen's decision.

WBA supported Van Hollen in his first race in 2006 and again in 2010 when he defeated former DNR Secretary Scott Hassett. Since becoming attorney general, Van Hollen has joined the WBA Board of Directors several times, twice serving at the master of ceremonies for the installation of WBA Officers.

Less than a week after the announcement, names on both sides of the aisle have already started to be discussed to replace Van Hollen. Waukesha County District Attorney Brad Schimel has already announced his intentions to run and has lined up the support of a number of county district attorneys throughout the state.

Current Deputy Wisconsin Attorney General Kevin St. John would be a logical candidate to also seek the GOP nomination.

Democrat State Representative Jon Richards of Milwaukee recently announced his intention to run for the open seat. Two current district attorneys are rumored to be looking at the post as well, Dane County District Attorney Ismael Ozanne and Milwaukee County District Attorney John Chisholm.

One possible candidate for the Democrats, and in my

opinion their best option, would be freshman State Representative Rob Kahl of Monona. Kahl has established himself as the go-to member of the Assembly Democrat Caucus on construction and most business issues and is a moderate voice that would be a strong candidate for A.G.

## Burke announces run for governor

Even before A.G. Van Hollen's announcement recently there was the YouTube video announcement by Madison School Board member Mary Burke that she was officially throwing her hat into the ring to run for Wisconsin Governor.

The YouTube video touts her Wisconsin roots and business experience working for the company her father started, Trek Bicycles in Waterloo.

Burke's announcement to enter the race was not a big surprise and was rumored to be in the works for months. It does appear that party leaders have made efforts to "clear the field" for Burke and it remains unclear if she will have a legitimate challenger in the Democrat primary for governor. State Senator Kathleen Vinehout of Alma is the candidate most mentioned as someone who may step up to also run but she would have to give up her state senate seat in 2014 to do so.
